Abortion is 97% of the "services" they offer pregnant mothers.

Planned Parenthood kills 1,076 preborn children every day.

- In *Planned Parenthood's* most recent annual report using "service" data from 2021 – 2022, they note the most recent number of *Planned Parenthood* abortions committed in a year (392,715). If you divide that number by the total days in a year, you see 1,076 babies on average are aborted a day in their facilities (392,715/365 = 1,075.9).

Planned Parenthood is the #1 abortion vendor in the country.

- *Planned Parenthood* commits around 40 % of all United States abortions. We know their share in the abortion market by dividing their latest abortion numbers by our nation's total number of reported abortions. *

In Kansas, *Planned Parenthood* is seeking to strike a law which helps protect women from being pressured into abortion.

- In the spring of 2024, *Planned Parenthood* filed a legal challenge against a new law, House Bill 2749, which requires abortionists to have discussions with abortion-minded women, including why they are interested in this option. By doing so, it gives opportunity for help to be given to a woman who is being pressured into abortion against her own inclinations. This is important as studies show an overwhelming majority of post-abortionive women report being coerced into their abortion.

In Illinois, *Planned Parenthood* fights against basic medical oversight, and the result has been many women injured and even killed — Tonya Reaves hemorrhaged to death in a Chicago *Planned Parenthood* because they waited nearly five hours to call emergency services.

- *Planned Parenthood* facilities in Illinois have long been embroiled in controversy over health and safety issues, due to reports coming out from state agencies that many *Planned Parenthoods* were unlicensed and had either never been subjected to a full health inspection or it had been years since their last one.

Only about 2% of the U.S. population will ever enter a *Planned Parenthood* in a given year.

- *Planned Parenthood's* latest annual report showed that they only worked with 2.05 million people last year — meaning the overwhelming majority of Americans are not stepping foot into their facilities.

Additionally, FQHCs have higher health standards and regular facility inspections, as well as more than **eight times** as many facilities serving women — but a *Planned Parenthood* facility still receives over three times more taxpayer money than an FQHC.

***Planned Parenthood* makes an obscene amount of money committing abortions while consistently making real health services for women obsolete in their facilities.**

- In their 2022 – 2023 annual report, *Planned Parenthood* reported nearly \$2.1 billion in income and more than \$2.5 billion in net assets, much of which came from private contributions and their sales. In overall profit, they made \$178.6 million.
- In contrast, *Planned Parenthood's* report also shows that authentic health services are going down. Prenatal services only accounted for 1.6% of business; adoption referrals 0.4%; and miscarriage care 0.9%. In fact, *Planned Parenthood* committed 228 abortions for every one adoption referral. - According to an analysis of *Planned Parenthood's* annual reports since 2010, these services have been on a downwards spiral for a while now. Contraceptive services are down by 39%; cancer screening and prevention services by 71%; and prenatal services by 80%. See this Charlotte Lozier Institute analysis at the link:

***Planned Parenthood* has been involved in multiple scandals, including the Texas Medicaid fraud, the baby body parts scandal, and the Mayra Rodriguez settlement.**

- Texas Medicaid Fraud: The state of Texas and an anonymous plaintiff are currently suing *Planned Parenthood* for \$1.8 billion after *Planned Parenthood* affiliates allegedly defrauded Medicaid through excessive overbilling after Texas terminated the organization as a provider in their Medicaid insurance program.

- Baby Body Parts Scandal: Videos from the Center for Medical Progress (CMP) have made it clear that it's not enough that *Planned Parenthood* profit off from killing preborn babies — they also want to profit off selling those dead babies' body parts afterwards. CMP has released multiple undercover videos of *Planned Parenthood* abortionists discussing the sale of aborted baby parts, with the most recent installment published on August 8, 2024. In this video, abortionists with a Texas *Planned Parenthood* affiliate laughed about looking for specific baby body parts when committing late-term abortions in order to sell

them. One staffer even joked about soliciting the sale of baby parts by saying "I have a leg for you" and "if other people were to hear me, they'd be like 'You are f**king evil.'"

- Mayra Rodriguez Settlement: Mayra Rodriguez was the director of three *Planned Parenthood* facilities, named *Planned Parenthood's* 2016 'Employee of the Year,' and worked with the organization for nearly 20 years – and became a whistleblower after seeing health and safety violations, women hurt, falsified records, unreported rapes, and further wrongs be swept under the rug at *Planned Parenthood*. When she spoke up, Rodriguez was harassed, exploited, and finally terminated. In a 2019 wrongful termination lawsuit against *Planned Parenthood*, she won \$3 million and proved *Planned Parenthood* will go to extreme measures to cover up their crimes.

Debarment is an "administrative remedy" used to prevent the government from working with/aiding parties who have demonstrated questionable ethics, honesty, or competence. *Planned Parenthood*...should be defunded and debarred.
